2. The selection & call for counseling of the candidate is provisional & does not guarantee admission. If any false information or discrepancy is observed at any stage of admission or the period of study, his/her candidature may stand cancelled.

3. Call letters will be sent individually to candidates on their registered email IDs as given by them in their application forms.

4. The course fee of Rs. 44,000/- (Rupees Forty Four Thousand only) excluding hostel fees is to be submitted at the time of counseling in the form of Demand Draft only. The Demand draft should be made in favour of "National Institute for Orthopaedically Handicapped" payable at "Kolkata". No other

method of payment of fees is acceptable including cash/cheque/etc. Hostel fee is to be paid separately after allotment of hostel in the concerned Institute. For candidates who will choose PDUNIPPD or get admission to PDUNIPPD, New Delhi, an additional amount of **Rs 7520/- is to be paid to PDUNIPPD**, New Delhi, at the time of reporting in addition to admission fees of **Rs 44,000/-**

5. The candidates will be called in the order of merit and shall be offered the seat and Institute available/vacant at his/her turn. Each candidate will have to select course and Institute (subject to eligibility) from the available seats at his/her rank.

6. Parents / guardian shall not be allowed in counseling hall. However, the candidate may be given enough opportunity to consult his / her guardian prior to counseling.

7. A candidate, who fails to report/appear in person on the notified date and time for counseling shall forfeit his/her claim for a seat.

8. The procedure of counseling will be followed as per the information mentioned in INFORMATION BROCHURE FOR COMMON ENTRANCE TEST (CET 2022).
