TERMS AND CONDITIONS

1. GENERAL:

1.1. The bid document consists of particulars of tender, general terms and conditions, price schedule and other necessary documents.

1.2. Location:

Main building at the campus of National Institute for Locomotor Disabilities (Divyangjan), B. T. Road, Bon-Hooghly, Kolkata 700090.

1.3. The work shall be executed as per current Indian Electricity Rules & CPWD General Specifications for Electrical work and as per relevant IS and as per directions of Engineer-in-Charge.

2. **COMMERCIAL CONDITIONS:**

2.1: Eligibility Criteria:

- 2.1.1. Percentage rate bids are invited from Eligible specialized firm/ agencies who are carrying out the similar type of works in PWD/CPWD or any other Government organization to undertake the work.
- 2.1.2. Self attested photo copy of satisfactory completion certificate of work as given below must be submitted with Tender documents:
 - (i) One similar work of value not less than **Rs. 1.30 Lakh** in any government/semi government or autonomous body during last three years ending May, 2019 .Or,
 - (ii) Two similar works, each of value not less than **Rs. 0.98 Lakh** in any government/semi government or autonomous body during last three years ending May, 2019. Or,
 - (iii) Three similar works, each of value not less than **Rs. 0.65 lakh** amount in any government/semi government or autonomous body during last three years ending May, 2019.

Similar type of works means E.I. work i.e. wiring in steel or PVC conduit, fixing of power points and switch boards etc.

The completion certificates must clearly indicate:

- a. The date of completion of work.
- b. Nature of work.
- c. That the work has been completed satisfactory.
- 2.1.4. 2.3. Issue, Submission and opening of Tenders:

2.3.1.

- a. Tender documents can only be downloaded from the web site (www.niohkol.nic.in). The cost of tender paper amounting to Rs. 500.00 which shall have to be deposited by the tenderer directly to the bank account of National Institute for Locomotor Disabilities (Divyangjan), Kolkata through online/ offline mode, on or before the last date of issue of tender paper. The copy of the transaction slip, duly signed by the tenderer, have to be submitted alongwith the bid document. The Duly filled in and signed tender paper will have to be submitted in the specified tender box at Civil Engineering Department in the presence of Engineering in Charge, NILD, Kolkata by the tenderers complete with the followings on or before 28.06.2019 at 2:00 pm.
- b. - 2.3.2. The Tenderers are advised not to deviate from the technical specifications, items, commercial terms and conditions of NIT like terms of payment, guarantee, arbitration clause, escalation etc.

- 2.3.4. Scrutiny/ evaluation of bid documents shall be done by the Tender Committee of NILD, Kolkata. - 2.3.6. In the bid document, submitted by the tenderer, shall be no condition whatsoever. In case any Tenderer mentions any condition including conditional rebates in their price part, Tender shall be rejected forthwith. A Tenderer will also not be allowed to withdraw or modify any condition after the technical bids have been.
- 2.3.7. The department reserves the right to reject any of or all the bids and go for fresh Tenders as the case may be without assigning any reason.
- 2.3.8. - 2.3.9. The successful Tenderer shall submit an irrevocable performance guarantee of 5% of the Tendered amount in addition to other deposits mentioned elsewhere in the contract for his proper performance of the contract agreement within 07 days from the date of acceptance of tender. This Performance Guarantee shall have to be deposited by the tenderer directly to the bank account of National Institute for Locomotor Disabilities (Divyangjan), Kolkata through online/ offline mode. completion of the job. Stipulations like levy of interest if payment is not made in specified time is not acceptable to the department.

3.1. Security deposit:

Security deposit shall be deducted from each running bill and the final bill to the extent of 10% of the gross amount payable. The security deposit shall be released on expiry of guarantee period stipulated in the contract.

4. COMPENSATION FOR DELAY:

The work is to be completed within the stipulated period. In case of delay a penalty $@1\frac{1}{2}$ percent per month computed on per day basis subject to the maximum of 10% of Quotation amount will be recovered from final bill.

5. Rates:

The rates quoted by the Tenderer shall be firm and inclusive of all taxes (including work contact taxes), duties and levies and all charges for packing, forwarding, insurance, freight and delivery, installation, testing, commissioning etc. at site.

Intending Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of the building, the form and nature of the site, the means of access to the site and in general shall themselves obtain all necessary information as to risk, contingencies and other circumstances which may influence or affect their bid. A Tenderer shall be deemed to have full knowledge of the site whether he inspect it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidders shall be responsible for arranging and maintaining at his own cost, all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the tender documents and made himself aware of the scope and specifications of the work to be done and of conditions and other factors having a bearing on the execution of the work. No T&P shall be issued by the department and nothing extra shall be paid in this regard.

6. COMPLETENESS OF TENDER:

All sundry equipment, fittings, termination lugs for electrical connections, dismantling of the existing electrical installations and all other items which are useful and necessary for installation of the work shall be deemed to have been included in the Tender irrespectively of the fact whether such items are specifically mentioned in the Tender document or not.

7. STORAGE AND CUSTODY OF MATERIALS:

The agency has to make his own arrangement for storage of materials & equipments. No separate storage accommodation shall be provided by the department. Watch and ward of the stores and their safe custody shall be the responsibility of the contractor till the final taking over of the installation by the department.

8. CARE OF THE BUILDING:

Care shall be taken by the contractor while carrying out the work to avoid damage to the building. He shall be responsible for repairing all damages and restoring the same to their original finish at his cost. He shall also remove at his cost all unwanted and waste materials arising out of the installation from the site of work.

9. COMPLETION PERIOD:

Time of completion of the total work is 60(Sixty) days from the date of issue of the work order as indicated in the Tender documents. The completion period is for the entire work of planning, supplying, mobilization of tools and manpower, installation, testing, dismantling the existing wiring, removing of unwanted and waste materials arising out of the installation from the Institute Campus etc. and handling over of the entire system to the satisfaction of the Engineer-in-Charge.

11. PERFORMANCE GUARANTEE:

- 11.1. The Tender shall guarantee among other things, the following:
- a. Quality, strength and performance of the materials used.
- b. Safe mechanical and electrical stress on all parts under all specified conditions of operation.

12. GUARANTEE:

All equipments shall be guaranteed for a period of **12 months** from the date of taking over the installation by the department against unsatisfactory performance. The equipments or components, or any part thereof, so found defective during guarantee period shall be forthwith repaired or replaced free of cost, to the satisfaction of the Engineer-in-Charge. In case if it is felt by the department that undue delay is being caused by the contractor in doing this, the same will be got done by the department at the risk and cost of the contactor. The decision of the Engineer-in-Charge in this regard shall be final.

19. VALIDITY:

Tenders shall be valid for acceptance for a period of 90 days from the date of opening of bid.

20. COMPLIANCE WITH REGULATIONS AND INDIAN STANDARDS:

- 20.1. All works shall be carried out in accordance with relavant regulation, both statutory and those specified by the Indian Standards related to the works covered by these specifications. In particular, the equipment and installation will comply with the following:

- 20.2. Nothing in this specification shall be construed to relive the successful Tenderer of his responsibility for the installation work with all accessories in accordance with currently applicable statutory regulations and safety codes.
- 20.3. Successful Tenderer shall arrange for compliance with statutory provisions of safety regulations and departmental requirements of safety codes in respect of labour employed on the work by the Tenderer. In addition, the department will be at liberty to make arrangement for the safety requirements at the cost of Tenderer and recover the cost thereof from him.

21. INDEMNITY:

The successful Tenderer shall at all times indemnity the department consequent on this works contract.
