TERMS & CONDITIONS

1. TERMS OF PAYMENT:

No advance payment will be made. The payment will be made on submission of the bill after completion of the job. Stipulations like levy of interest if payment is not made in specified time is not acceptable to the department.

2. Security deposit:

Security deposit shall be deducted from each running bill and the final bill to the extent of 10% of the gross amount payable. The earnest money deposit shall be adjusted with this security deposit. The security deposit shall be released on expiry of guarantee period stipulated in the contract.

3. COMPENSATION FOR DELAY:

The work is to be completed within the stipulated period. In case of delay a penalty @ 1½ percent per month computed on per day basis subject to the maximum of 10% of Quoted amount will be recovered from final bill.

4. Rates:

The rates quoted by the Quotationer shall be firm and inclusive of all taxes (including work contact taxes), duties and levies and all charges for packing, forwarding, insurance, freight and delivery, necessary dismantling and modifications, installation, testing, commissioning etc. at site.

The rate should be quoted by the Quotationer only in the Price Schedule of this Quotation document.

5. COMPLETENESS OF QUOTATION:

All sundry equipment, fittings, termination lugs for electrical connections, and all other items which are useful and necessary for installation of the work shall be deemed to have been included in the Quotation irrespectively of the fact whether such items are specifically mentioned in the Quotation document or not.

6. STORAGE AND CUSTODY OF MATERIALS:

The agency has to make his own arrangement for storage of materials & equipments. No separate storage accommodation shall be provided by the department. Watch and ward of the stores and their safe custody shall be the responsibility of the contractor till the final taking over of the installation by the department.

7. CARE OF THE BUILDING:

Care shall be taken by the contractor while carrying out the work to avoid damage to the building. 8. COMPLETION PERIOD:

Time of completion of the total work is 30 days from the date of issue of the work order as indicated in the Quotation documents. The completion period is for the entire work of planning, supplying, mobilization of tools and manpower, installation, testing, dismantling the existing wiring, removing of unwanted and waste materials arising out of the installation from the Institute Campus etc. and handling over of the entire system to the satisfaction of the Engineer-in-Charge.

9. PERFORMANCE GUARANTEE:

The Quotation shall guarantee among other things, the following:

- i. Quality, strength and performance of the materials used.
- ii. Safe mechanical and electrical stress on all parts under all specified conditions of operation.

10. GUARANTEE:

All equipments shall be guaranteed for a period of 12 months from the date of taking over the installation by the department against unsatisfactory performance. The equipments or components, or any part thereof, so found defective during guarantee period shall be forthwith repaired or replaced free of cost, to the satisfaction of the Engineer-in-Charge. In case if it is felt by the department that undue delay is being caused by the contractor in doing this, the same will be got done by the department at the risk and cost of the contactor. The decision of the Engineer-in-Charge in this regard shall be final.

11. VALIDITY:

Quotations shall be valid for acceptance for a period of 90 days from the date of opening of bid.

No tools and tackles required for installation purposes would be made available by the department. The successful Quotationer shall make his own arrangement for all these facilities.
