#### **Terms and Conditions**

- **01**. The filled-in Tender documents along with credentials and along with **EMD Rs.5000/**should be submitted by 2.30 pm on 10.11.2014 and should be opened at 4.30 PM on 12.11.2-14. This is schedule rates of tender; the agencies should quote the rates per unit basis including supply and installation charges.
- 02. The complete set of Tender documents duly signed on all pages and supported with requisite credentials and EMD should be submitted in a sealed cover addressed to the Director, NIOH, Kolkata-700 090 within specified date, failing which the offer should be treated as cancelled. Name of the Work should be written on the top of the cover clearly.
- 03. Telegraphic and conditional offer shall not be accepted. Tenderer should be in this trade for not less than 5 years. Tenderer should have similar experience for at least in Two Government Organizations / Undertakings where 15 or more equipments were in use.
- **04.** All the Fire Extinguishers of types mentioned (IS Codes) in the schedule should be Refilling/Recharging with their appropriate standard for their quality / reliability. No additional payment should be made as transportation charge. The Fire Extinguishers refilling works to be carried out in our Institute premises only.
- **05**. Care should be taken while transportation and installation of the Extinguishers at various locations that no damage is made to any of the existing installation and if so should be made good by the agency at their risk and cost.
- **06.** 10% of your bill including of EMD should be deducted as **Security Deposit** and shall be refunded after 12 months of satisfactory completion of your work and reliability of the units without interest..
- 07. EMD should be refunded to the un-successful bidders after finalization of the Tender process and award of the work without interest.
- 08. IT & ST, VAT should be deducted from your bill as per the rule.
- 09. Warranty: 1 year from the date of completion. During the warranty, the necessary regular/periodical check up by the supplied party for damage, leakage, if any found.
