CIRCULAR

Sub:- Medical benefits to the retired employees of the Institute.

In pursuance to the decision taken in the 109th meeting of the Executive Council of the Institute, EC approved the proposal for extension of Medical facility to the retired employees during hospitalization as per the CS(MA) Rules subject to following conditions

1	Option has to be exercised by the retired employees of the Institute for availing the medical facility during hospitalization.
2	Fixed Medical Allowance (FMA) to the pensioners will be discontinued for the retired employees opted for the facility.
3	The facility may be extended to the retired employees, pensioners including family pensioners against collection of prescribed contribution in accordance with Office Memorandum No.S.11011/2/2008-CGHS(P) dated 20-05-2009 and Office Memorandum No.S.11011/11/2016-CGHS(P)/EHS dated 09-01-2017. Ministry of Health, Govt. of India.
4	Treatment to be done as per CGHS Rate only and to be availed from the CGHS empanelled hospitals.
5	NPS beneficiaries can also avail/opt for the facility against payment of matching contribution as per para-3 above.

It is also informed that the retired employees of the Institute should avail services from the said Hospitals or in emergency cases, should inform the name of the patient/spouse member immediately after admission to obtain its endorsement from this Institute to facilitate the services.

This is issued with the approval of the Competent Authority.
